**Twenty-one Additional Residents Test Positive & City Learns of four new COVID-19-related fatalities;**  
*May 12 Zoom Community Hour Focused on Framingham Businesses Amid the Pandemic*

- **Twenty-one additional residents test positive for COVID-19, and City learns of four new fatalities:** The number of people in the City who have tested positive for COVID-19 is now 1,191. With 302 cases recovered and 46 fatalities, Framingham currently has 843 active cases. The Framingham Health Department contacts the people who were potentially exposed and the owners of the businesses or places of employment where the potential exposures occurred to inform and counsel them on next steps (contact tracing). In addition to the active cases, the Framingham Health Department currently is following 276 residents in quarantine.
