## **\*COVID-19 UPDATE\***

**Five Additional Residents Test Positive, 82 People have Recovered, and  
City Learns of One New COVID-19 Fatality;**  
*Additional City Facilities to Open Monday, June 8, 2020*

- **Five additional residents test positive for the virus, 82 more have recovered, and City learns of one new COVID-19 fatality:** The number of people in the City who have tested positive for COVID-19 is now 1,679. With 1,099 cases recovered and 96 fatalities, Framingham currently has 484 active cases. The Framingham Health Department contacts the people who were potentially exposed and the owners of the businesses or places of employment where the potential exposures occurred to inform and counsel them on next steps (contact tracing). In addition to the active cases, the Framingham Health Department currently is following 149 residents in quarantine.
- **Framingham to open additional facilities Monday, June 8:** The following City facilities will be open to the public Monday, June 8:
  - The lobby of the Framingham Police Department, 1 William H Welch Way, 9 a.m. (Open for administrative purposes. Permit applications will require an appointment.)

Last week, the City [announced the partial reopening of City Hall](#). Each facility will undergo cleaning and disinfecting each day after people leave. Per [Governor Baker's Order](#) and the [City of Framingham's Emergency Order](#), face coverings will be required for entry into any City facility. Residents are also asked to practice social distancing.
