COVID-19 UPDATE

Since Friday, July 17, 16 Residents have Tested Positive, Six More have Recovered, and City Learns of One New Fatality Related to COVID-19;

Health Department Distributes Demographic COVID-19 Data;

Focused on Framingham's Older Adults Amid COVID-19: The Past Three+ months and the Future

- **Since Friday, July 17, 16 residents have tested positive, six more have recovered, and City learns of one new fatality related to COVID-19:** The number of people in the City who have tested positive for COVID-19 is 1,772. With 1,562 recovered and 120 fatalities, Framingham currently has 90 active cases. The Framingham Health Department contacts the people who were potentially exposed and the owners of the businesses or places of employment where the potential exposures occurred to inform and counsel them on next steps (contact tracing). In addition to the active cases, the Health Department is following 76 residents in quarantine.
- **The City's Department of Public Health distributes demographic COVID-19 data every Monday on all confirmed Cases in Framingham since March 1, 2020:** Data includes information about confirmed cases by age, gender, race/ethnicity, fatalities, nursing homes, and residential settings.
